## Annual Registration - All Programs!

**Date:** Starting September 7, 2021 (Online Only)

**How:** By getting ticket to reserve your spot at [esfamily.org](http://esfamily.org)

### *Important things to know...*

- \* Fortunately for this current program year, **children under one (1) year** or 12 months, will be permitted in the ESFRA Centre during normal business hours.
- \* All Programs, including Virtual and Drop-In Programs, require Tickets/Registration.
- \* Each Child will require a separate Registration form.
- \* Only One (1) program per child per semester. (e.g. If a child is attending Bookworms in semester 1, they cannot attend semester 2 but may choose another program.)
- \* If you are expecting to “grow” your family over the 2021-22 program year, please be aware due to current Health Protocols, only registered children will be allowed in Programs.
- \* Childcare providers can bring additional children in their care as long as the below ratios are met and each child’s form is filled out in full and signed by the parents/legal guardians.  
Child ratios are as follows:
  - ➔ 1 Adult bringing 1 Child to Ready to Play will be allowed to bring one (1) additional child to this programs. (Total = 1 adult & up to 2 children)
  - ➔ 1 Adult bringing 1 Child UNDER 18 mos. will be allowed to bring 1 additional child **over** 18 mos. (Total = 1 adult & 2 children)
  - ➔ 1 Adult bringing children OVER 18 mos. will be allowed to bring 3 children **over** 18 mos. (Total = 1 adult & 3 children)
- \* Ratio exceptions for families will be determined on a case by case basis for families with multiple children.

**\*\*Please note: The Eastern Shore Family Resource Association is very concerned for our participants enjoyment and safety. Hence due to these concerns and liability, 1 adult attending a program is restricted to the number of children they can bring to programs.\*\***
